Troubling Portion of Global Warming Agreement/Treaty Draft President Obama could sign at Summit in December (Copenhagen)

These sections 36 & 38 of the Treaty draft are very concerning:

“**36.** The new agreed post-2012 institutional arrangement and legal framework to be established

for the implementation, monitoring, reporting and verification of the global cooperative action for mitigation, adaptation, technology and financing, should be set under the Convention. It should include a

financial mechanism and a facilitative mechanism drawn up to facilitate the design, adoption and carrying out of public policies, as the prevailing instrument, to which the market rules and related dynamics should be subordinate, in order to assure the full, effective and sustained implementation of the Convention.

38. The scheme for the new institutional arrangement under the **Convention will be based on three basic pillars: government; facilitative mechanism; and financial mechanism, and the basic organization of which will include the following:**

(a) **The government will be ruled by the COP** with the support of a new subsidiary body on adaptation, and of an Executive Board responsible for the management of the new funds and the related facilitative processes and bodies. The current Convention secretariat will operate as such, as appropriate.”
